1. Booths: To secure booth space, a completed application, signed contract, and payment must be received no later than June 15, 2021.
2. Booths: A Business description should be 1 short paragraph up to 10 sentences. A website address along with a mailing address, phone number, email and hours of operation.
 - a. Images should be 512 by 512 pixels for rectangular images, we recommend portrait view
 - b. Please send all digital artwork to revjwhite2@theit.org
3. Payment and Cancellation: Each vendor booth costs \$500.. Full payment for the space must accompany the application and signed agreement. Proof of eligibility for Candidates should accompany application before space is assigned. Vendors may cancel this agreement by written notice to the organizers. No refunds will be made on cancellations made on June 21, 2021 or later.
4. Limitation and Liability: The vendor shall indemnify the AME Church against all claims, demands, actions, expenses, damages, penalties, or proceedings arising out of or in any way connected with the exhibitor's occupancy and use of the exhibition premises or any part thereof. Vendors will be required to meet the cost of making good any damage to floors, walls, structures, and accessories.
